It is understood all terms, conditions and prices will be held firm as per your response to the bid. This bid supersedes Bid Number 0809-072.

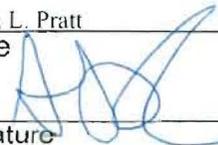

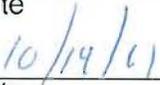
