Case Information

To obtain information about the status of a death investigation contact the Police Department Criminal Investigations Division (CID) and request to speak with the investigator assigned to the case.

The case number will be the number that was provided by the responding officers at the time of the original call. All report numbers are assigned sequentially from Jan 1 to Dec. 31st. (Sample report number 11-00001).

If you do not know the report number that was assigned to the case you can request to speak with a Records Clerk who can assist you in locating the case number.
